



STREAT is an independent hospitality and horticulture social enterprise that provides supported pre-vocational training and holistic personal support to young people aged 16-24 who need a hand.

Courtesy of funding from the Commonwealth Department of Home Affairs, STREAT has expanded our highly successful **Fast-Track to Work** program to welcome refugee and humanitarian entrants with low literacy or limited education.

STREAT's **Refugee Fast Track to Work** program will increase work readiness and employment opportunities for refugees and humanitarian entrants with low education or English language. As with all STREAT trainees, our goal is for young refugee and humanitarian entrants feel they belong, with a healthy sense of self, home and work.

ABOUT STREAT'S FAST TRACK TO WORK

The first phase of the **Refugee Fast Track to Work** is a supported 8-week work-readiness program for young people facing barriers to employment who are seeking work in hospitality and/or horticulture. This holistic program requires approximately 18 hours per week which can be spread over as few or as many days as works for the young person.

Our Youth Programs Team run experiential workshops focusing, including self-care, basic living skills, budgeting, healthy relationships, teamwork, self-regulation, emotional regulation, legal rights, employee rights, interview skills.

The second phase of **Refugee Fast Track to Work** includes:

- *Paid employment for nine months in hospitality or horticulture*
- *Intensive post-placement support for both the young person and the employer for the nine months*
- *On the job training*
- *An opportunity to continue employment with partnered employers once the program has completed*

Refugee Fast Track to Work prepares and equips young people with the essential knowledge and skills to transition into the workforce with greater confidence and aptitude.
